Chief Administrative Law Judge Honorable Walter J. Brudzinski

Hon. Walter J. Brudzinski is the Chief Administrative Law Judge, U.S. Coast Guard. Coast Guard Administrative Law Judges adjudicate Merchant Mariner Credential suspension and revocation cases that the Coast Guard initiates against Credential holders for misconduct, negligence, violations of law or regulation, incompetence, and use of dangerous drugs. Coast Guard Judges also adjudicate cases for other federal agencies such as the Transportation Security Administration.

He has lectured extensively and published numerous articles on administrative law and Merchant Mariner suspension and revocation proceedings dealing primarily with use of dangerous drugs in publications such as the Journal of Maritime Law and Commerce, the Maritime Logistics Professional, and the Proceedings of the Marine Safety and Security Council, among others. He earned his B.A. from the University of Maryland, his J.D. from George Mason University School of Law (with distinction), and his M.J.S. and Ph.D. in Judicial Studies from the University of Nevada. He also a graduate of the National Judicial College.

Harold Watson

Harold K. "Hal" Watson is a partner in the Houston office of Chaffe McCall LLP. Hal is the Immediate Past President of the Maritime Law Association of the United States and has over 40 years' experience practicing maritime law representing marine insurers, shipowners, charterers, P&I clubs, drilling contractors, and other entities active in the shipping and offshore energy industries. He has particular expertise in marine and energy insurance law and has been involved in numerous major marine and energy insurance cases, including the cases that established the boundaries of coverage for wreck removal under U.S. law. 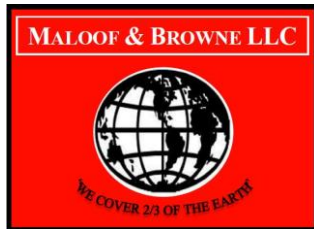
